Dr. Maureen Carrigan



#### New EEG Coming this Year

This year, Dr. Swain was awarded a competitive Major Research Instrumentation Grant from NSF for over \$150,000 (have we mentioned how awesome she is?!). This grant will allow her to buy us a brand new EEG system! This system will allow us to stay at the cutting edge of neuroscience research, which is a popular area of study for our students. 


#### Hannah Milius

# We're Up for Re-Accreditation!

As you know, we are accredited by the Masters in Psychology and Counseling Accreditation Council, which accredits academic programs that provide science-based education and training in the practice of counseling and psychological services. This accrediting body ensures that all programs receiving accreditation are providing high-quality science-based educational experiences to their students. Re-accreditation is now required every eight years, and this year we're up!

What does that mean for you?

If you're a recent alumnus of our program, you'll be invited to participate in our site visit in the next six months or so. Keep an eye out for an email from Dr. Carrigan inviting you to participate! This is an important process that allows us to understand our strengths and weaknesses as a program so we can continue improving our graduate program year after year.

As always, your feedback in particular is incredibly valuable and often results in change! You can read about those changes below.

# Program Changes

We recently solicited feedback from graduating students, alumni, and our external supervisors to learn how we could improve the program. All three groups thought that the training we provide was high-quality, and noted particular strengths in our students' skills in assessment and diagnosis and their ability to develop a strong therapeutic alliance. That said, the surveys illuminated a few areas of growth for us that we are actively making changes to accommodate. Check them out below!

- 1. <u>New Course Offerings:</u> Several current students and alumni noted that our program would benefit from including formal training in trauma psychology and child and family therapy. In response to this feedback, Dr. Cho developed a trauma psychology course that will now be required for all students and a child and family therapy course that will be regularly offered as a special topics class starting this fall.
- 2. <u>Electronic Health Records:</u> As you probably know, we don't currently have an electronic health record system in our clinic. Students have mentioned that they wished they had experience with electronic health records since they're standard in practices that take insurance. This spring, Dr. Moussa Rogers applied for a grant that, if funded, would allow us to purchase an electronic health record system. We are still waiting to hear back, but this is a priority for us, and we feel hopeful that her grant application will be funded if not this year hopefully next!
- 3. Integrated Ethics Education: Another piece of common feedback we received was that although students feel our ethics course is comprehensive (shout out to Dr. Carrigan!), students realize when working with clients that ethical dilemmas come up more frequently than they'd anticipated, and the answers are not always black-and-white. Although including a second ethics course later in the program isn't feasible, our clinical faculty are committed to explicitly discussing real-world ethical concerns during supervision and practicum and throughout the curriculum.

# Looking Forward

There is a lot of excitement on the horizon for the USCA Psychology Graduate Program!

With Dr. Callen's retirement and no remaining psychologists doing animal research, we have decided to renovate the rat lab into a new-and-improved clinic space! Renovations have begun (see above photo) and we hope they will be finished by the end of summer. For those of you who visited our previous clinic, you know that the hallway was cramped at times which didn't make for the best waiting area. Our new clinic will feature a large waiting room with a reception desk, comfortable chairs, and even a play area for child clients! We will still have three treatment rooms, but these will be bigger and newly updated. We are so glad to offer our services in this newly updated space!

This coming fall, we will welcome 17 (!) incoming first year graduate students as we continue working with the 11 returning second year students. We are excited to meet the incoming cohort and help them transition into graduate school.

In 2022, we made a change to our curriculum such that we removed the requirement of a formal thesis for graduation from our program. That said, research remains a primary value of ours, and although a formalized thesis manuscript is no longer required, all students are required to complete an original research project which is presented to the faculty at a departmental poster session in the spring. Although the thesis is not required, some students still choose to complete one, and all benefit from our dedication to research training. Already, several of our rising second-years have begun working on their research projects, many of which will be submitted to this year's meeting of the Southeastern Psychological Association in Atlanta this spring.

We so appreciate your continued support of our program. We feel so grateful for our connections to current and former students and the broader Aiken community. We would not be here without you.
